

REQUEST FOR CURRENT FIRE SAFETY INSPECTION

The Certification for Youth Camps Regulations, COMAR 10.16.06.46, requires an operator to ensure that a camp is in compliance and approved by the State or county fire authority. A fire safety inspection must be made each year. Refer to the chart below. When the Fire Marshal office requires the request from the licensing agency, the Maryland Department of Health and Mental Hygiene (DHMH), Division of Community Services requests the fire safety inspection for each youth camp. When the Fire Marshal office requires the request directly from the camp operator, you must request the fire safety inspection. When indicated, please submit a request for inspection **at least 30 days before the camp opens.**
