**DIRECTIONS:**

Annapolis - Anne Arundel Co Health Services Bldg, 3 Harry S. Truman Parkway  
From US Route 50, take Exit 22 (Rt 665). Take first Exit, Riva Road, turn right onto Riva Road. Go 0.4 mile and turn right onto Harry S. Truman Parkway. Go 0.5 mile, Anne Arundel County Health Services Bldg is on left hand side. Park in lower lot and use main entrance on upper level. Guard will direct you to the Conference Room A1 & 2 on the lower level.

Baltimore City - Dept of Health & Mental Hygiene, 4201 Patterson Avenue, Room 108/109  
From Baltimore Beltway, I-695, take Exit 20, Reisterstown Road South. Go approximately 2.5 miles to Patterson Avenue. Turn right onto Patterson Avenue (after Reisterstown Road Plaza Shopping Center). Five story building on left.

Howard County - Howard Co Health Department, 7178 Columbia Gateway Drive, Columbia  
From US I-95, take Exit 41, MD Rt 175 West, toward Columbia. Take Columbia Gateway Drive Exit, at 3<sup>rd</sup> light make right (still on Columbia Gateway Drive) and make 1<sup>st</sup> left at 7178, look for blue Health Department sign. Conference Room A.
