Dear WIC Vendor:

Enclosed is the Maryland WIC Program's 2015 Annual Vendor Training Schedule. Annual Training will be conducted during the month of August, 2015. As a requirement of your WIC vendor authorization, and in accordance with Code of Maryland Regulations 10.54.03.15B(1)(r), all authorized vendors must have a representative attend and participate in at least one State or local agency interactive training session each calendar year. **Cashier training does not count toward fulfillment of this requirement.** Failure to satisfy the annual training requirement may result in the disqualification of your store's WIC authorization.

Organizations owning or operating more than one WIC authorized store can, at their option, choose to send one representative for all of the stores. If you choose this option, please check the box on the Registration Form enclosed. The representative attending will be responsible for sharing the information provided at Annual Vendor Training with all of the stores being represented.

The schedule of specific training dates and times is included with this correspondence. Vendors may attend training at any location on any of the dates listed on the schedule. **Prior registration is required for all locations.** Copies of the schedule and registration form are attached. Seating capacities are indicated for each location and will be strictly followed. Vendors and/or their representatives will be scheduled on a first come, first serve basis.

From the north or the south take I-95 and exit onto I-395. Take Martin Luther King Blvd. to Eutaw Street. Turn left and take the first right onto West Preston Street. 201 is the second building on the right. The Metro and Light Rail also serve this location. Plan to arrive early to find parking; on street parking is very limited. There is a pay parking lot across the street that accepts cash only.

From Annapolis: Take 97 North to 695 East. Use Exit 17 B (Key Bridge, Dundalk). Merge onto the beltway. Take Exit 3A (Route 2 North, Brooklyn). Turn or bear right at the stop sign and then turn right onto Route 2. Turn right at the 3rd light (16th 2 North, Brooklyn). Turn or bear right at the stop sign and then turn right onto Route 2. Turn right at the 3rd light (16th Avenue). The Training Center is in the strip of storefronts directly behind Taco Bell and Long John Silvers.
